**ORDER OF DISMISSAL**

On September 12, 2005, the Federal Aviation Administration (hereinafter "Complainant") filed a Complaint. On August 15, 2005, Tyoka Jackson (hereinafter "Respondent") filed a Request for Hearing. On September 28, 2005, Respondent filed an Answer.

On March 24, 2006, eleven (11) days prior to the hearing, Complainant withdrew the Complaint, stating the parties have settled the matter.

14 C.F.R. § 13.215 states: "At any time before or during a hearing, an agency attorney may withdraw a complaint or party may withdraw a request for a hearing without the consent of the administrative law judge. If an agency attorney withdraws the complaint or a party withdraws the request for a hearing and the answer, the administrative law judge shall dismiss the proceedings under this subpart with prejudice."

WHEREFORE, the within filed Withdrawal of Complaint having been read and considered, it is ORDERED as follows:

1. This proceeding be and is hereby dismissed with prejudice; and

2. Agency counsel shall send to the Judge and the Hearing Docket a copy of any order that the settlement produced.
