NOTICE OF ASSIGNMENT OF PROCEEDING

In an order served August 30, 2007, Respondent's request that this matter be adjudicated by informal hearing pursuant to 49 C.F.R. 386.16(b)(1) and 49 C.F.R. 386.16(b)(4)(i)(A) was granted. This matter is assigned to Hearing Officer Lorraine C. Ehret.

The revised Rules of Practice,² at 49 C.F.R. 386.7(a), require a signed original and one copy of each document submitted for the consideration of the Hearing Officer to be personally delivered or mailed to U.S. DOT Dockets. Nevertheless, because the Hearing Officer will attach all submissions to her report, which she will serve upon U.S. DOT Dockets (see below), no service of documents on U.S. DOT Dockets by the parties is necessary. Each party will serve the original of each document upon the Hearing Officer with a copy to the representative or representatives of the other party, as listed in the attached certificate of service.


Within 45 days after conclusion of the hearing, the Hearing Officer shall submit a written report to the Assistant Administrator containing findings of fact and a

recommended disposition of the matter pursuant to 49 C.F.R. 386.16(b)(4)(i)(A) and 49 C.F.R. 386.61(b). That report, which will be the sole record of the proceeding, shall contain as attachments all documents received from the parties by the Hearing Officer. The original report of the Hearing Officer shall be served upon U.S. DOT Dockets, with a copy to all other persons listed on the attached certificate of service.
