**ADMINISTRATIVE LAW JUDGE'S NOTICE OF  
PREHEARING CONFERENCE AND HEARING DATE**

A prehearing conference in this proceeding will be held by telephone on October 21, 2005 at 10 a.m., Eastern Time. All parties must attend the conference personally or by a representative who has authority to negotiate for resolution of the issues in controversy.

The conference will provide the opportunity for a discussion of the facts, the law, and the positions of the parties and for resolution of any outstanding issues related to discovery. Deadlines will be fixed for the exchange of witness lists and of copies of documents intended to be offered in evidence. The conference will also consider requests for a change in the date, place and time of the hearing; however, the parties are urged to consult with each other and agree on such a change before requesting it.

The hearing in this proceeding is scheduled to take place on November 21, 2005 in courtroom 238, Jacob K. Javits Federal Building, 26 Federal Plaza, New York, NY 10278 commencing at 2 p.m., Eastern Time, or as soon thereafter as the parties can be heard. If, for some reason, it is necessary to change the date, time or place of the hearing, the parties will be notified. To this end, all parties should promptly notify me of the name, address and telephone number of each person who is expected to attend the hearing on their behalf, as well as the nature of the electronic equipment (e.g., laptop computers) such persons may bring to the hearing.

(The courts often require us to provide a list of such persons and equipment in advance of the hearing date.) Please note that portable electronic devices, such as cameras and cell phones containing cameras, are generally not allowed in federal courthouses.
