The revised Rules of Practice,<sup>1</sup> at 49 CFR 386.7(a), require a signed original and one copy of each document submitted for the consideration of the hearing officer to be personally delivered or mailed to U.S. Department of Transportation Docket Operations. Nevertheless, because the hearing officer will attach all submissions to her report, which she will serve upon Docket Operations (see below), no service of documents on Docket Operations by the parties is necessary. Each party will serve the original of each document upon the hearing officer with a copy to the representative or representatives of the other party, as listed in the attached certificate of service.


Within 45 days after conclusion of the hearing, the hearing officer shall submit a written report to the Assistant Administrator containing findings of fact and a recommended disposition of the matter pursuant to 49 CFR 386.16(b)(4)(i)(A) and 49

CFR 386.61(b). That report, which will be the sole record of the proceeding, shall contain as attachments all documents received from the parties by the hearing officer. The original report of the hearing officer shall be served upon Docket Operations, with a copy to all other persons listed on the attached certificate of service.
