**ADMINISTRATIVE LAW JUDGE'S ORDER CONSOLIDATING
CASES FOR HEARING AND INITIAL DECISION**

The Complainant Federal Aviation Administration in these two cases has filed a motion to consolidate them for the purposes of the hearing and initial decision. As the Complainant points out in its motion papers both cases arose out of the same incidents, and the witnesses in both cases will be the same people. Hence, resources can be saved and parties will be inconvenienced if the cases are consolidated and heard at the same time, with a single initial decision issued after the hearing.

For these reasons, the pending motion to consolidate the cases is granted.

The cases will be heard on January 15, 2009, in Hartford, Connecticut. A separate notice will be issued giving the exact location and time of the hearing.

Notwithstanding this consolidation, each of the Respondents is entitled to be represented by his own separate counsel, each of whom is entitled to examine the witnesses sponsored by the Complainant.
