Dear Congressman Lampson:

Thank you for your letter of October 23, supporting a request by American Airlines, British Airways, Iberia Airlines, Finnair, and Royal Jordanian for a grant of antitrust immunity to operate an integrated alliance. The Secretary has asked that I respond on her behalf.

The U.S. Department of Transportation's review of this request is part of a public proceeding in which interested parties have the opportunity to comment. The Department carefully considers all requests for antitrust immunity, beginning with a review of the record to assess whether there is sufficient information to make a reasoned decision that satisfies all statutory requirements. Decisions regarding requests for antitrust immunity are made after consultation with the Department of Justice, and are based upon statutory standards that include antitrust principles. As this proceeding is pending, I am sure you understand that I cannot comment on the merits of the case. I assure you, however, that the Department will give full and fair consideration to the Joint Applicants' request, as well as all comments in the docket.

As is our normal practice, I am placing a copy of your letter and this response in Docket OST-2008-0252 as a contact outside the record in this matter. I appreciate your interest in this proceeding. An identical letter has been sent to each cosigner of your letter.

Dear Madame Secretary:

On behalf of the Texas Congressional Delegation, we are writing to convey our strong support for the joint application for antitrust immunity recently filed by American Airlines in conjunction with its transatlantic oneworld partners—British Airways, Iberia Airlines of Spain, Finnair, and Royal Jordanian. We strongly encourage your expeditious review of this application and urge its approval by the Department of Transportation (DOT).

Thank you, Madame Secretary, for your consideration. DOT's approval of this application will enhance competition while simultaneously generating significant benefits for our Texas

community—new and expanded transatlantic service, integrated corporate contracts, fare combinability, reciprocal frequent flyer programs, and facility rationalization.


